3.1. Maps of Maritime Routes of the Greater Caribbean

Havana Plan of Action.

- Implement phases IV and V to show the existing regular container line maritime transport services, their frequency and the locations of different shipping line agents by ports-of-call found on the interactive map posted on ACS, Central American Commission for Maritime Transport (COCATRAM) and Maritime Authority of Panama (AMP) regularly updated webpages.

3.1. Maps of Maritime Routes of the Greater Caribbean

STATUS

- Cuban initiative and authorship. ACS. TD. 1999.
- Increase intraregional maritime transport and trade. 2007. Cuban Ministry of Transport, COCATRAM and Panama Maritime Authority.
- Currently in phases IV and V funded by the Government of Mexico, \$30,000.00. May 2015.
- 100 ports in the Greater Caribbean-277
- Website with over 10000 visits from thousands of users; importers, exporters, vendors, buyers, etc.
- Previous phases funded by Korea (\$35,000. 2007), ACS-Turkey (\$35,000. 2010) In 2011-2012 (45,000)
- Funding needed for 2017

3.2.1. Senior Port Management Course

Havana Plan of Action.

- Put in practice recommendations of the Study on Port and Maritime Strategies for the Greater Caribbean, in particular actions designed to benefit the development of small maritime ports.
- Capacity building at senior level in small ports.

3.2. The Greater Caribbean Port and Maritime Strategy.

3.2.1. Senior Port Management Course

STATUS

- Terms of Reference for the Caribbean Maritime Strategy developed by COCATRAM, Ministry of Transport, Cuba and AMP of Panama.
- Study funded by the Agence Française de Development (AFD). € 125,000. 2014.
- Consulting firm conducted Study on Port and Maritime Strategies for the Greater Caribbean in 2014.
- Draft Report presented in Seminar in Cartagena, Colombia in July, 2014.
- Final Report and translations in early 2015
- Planning of a Senior Port Management Course Started (ACS, IMO, PMAC)

3.2. The Greater Caribbean Port and Maritime Strategy.

3.2.1. Senior Port Management Course

Activities 2017-2018

- Revision Terms of Reference for the Caribbean Maritime Strategy developed by COCATRAM, Ministry of Transport, Cuba and AMP vs. Study and Conclusions
- Identification of Activities to develop the Strategy.
- Final Design, funding and delivery of Senior Port Management Course.
- Convene expert meeting and design needs-based surveys to further define initiatives for the enhancement of small ports. (WP)



3.3. Continuing efforts for connectivity

3.3.1. Air Transport Agreement among Member States and Associate Members of the ACS.

Havana Plan of Action.

- Continue to promote the implementation and updating of the Agreement in order to meet the need of a general aviation policy for the Greater Caribbean, establishing a legal and co-operation framework that would offer more air service options with reduced costs and prices, more routes, more carriers and improved services, as well as attaining the highest levels of operational safety and protection for international civil aviation.



3.3. Continuing efforts for connectivity

3.3.1. Air Transport Agreement among Member States and Associate Members of the ACS.

STATUS:

- Agreement signed in 2004
- Entered into force on September 19th, 2008
- 13 ratifications to date.
- Last accession in April 17th, 2014.
Cooperative Republic of Guyana.
