

1.- GENERAL INFORMATION ABOUT TRINIDAD AND TOBAGO

The Republic of Trinidad and Tobago comprises two islands at the southern-most end of the Caribbean archipelago with an area of $5,128 \text{ km}^2$. Port of Spain is the capital city and the currency is the Trinidad and Tobago dollar (**U.S. \$ 1 = TT\$ 6.40**). The country has the largest commercially viable source of natural asphalt in the world, with the official language being English, and the population being 1,310 million people. The Honourable Kamla Persad-Bissesar is the Prime Minister, the Honourable Anthony Carmona, President, and the Honourable Winston Dookeran, Minister of Foreign Affairs.

June and July mark the beginning of the rainy season and are the wettest months of the year with an average of nineteen (>=1mm of rain). The areas in and around Port of Spain may experience half day / early afternoon thundershowers after a sunny morning.
